All new students must complete and provide the following information to be admitted into Valley Crescent School:

PROGRAMS

I.C. (Islamic Class) Half-day classes for students aged 4-5. The I.C. begins at 8:00 am with a break and lunchtime. Students are picked up at 12:00 pm. Islamic Principles, along with basic Islamic etiquette, are immersed in the teaching of pre-kindergarten education.

Full Day Kindergarten Rationale. Extended-Day Kindergarten is defined as a class taught by the staff that exceeds the four-hour maximum number of school day minutes. In 2009, about two-thirds of United States kindergarten children attended full-day classes. In California, the percentage of students in full-day classes increased by 43%. For further information visit The Public Policy Institute of California Web site on Full-Day Kindergarten in California. Reasons to extend the Kindergarten Day include the following:

- To improve the educational program
- To provide more time for the teacher to get to know each child.

- To encourage children's maximum social, emotional, physical, and academic growth
- To address transportation issues related to parents and schools.
- To address parental/guardian needs for childcare

First Through Fourth Grade Students at Valley Crescent School are taught the California State Standards. The teachers use an updated curriculum, which is considered College-and-Career Ready.

Middle School students follow a public-school model and have different teachers for each subject, but have a homeroom teacher as well. The students are administered standardized testing annually using CTBS-Terra Nova, based on College and Career Readiness Standards.

Islamic Studies: All students K – 8 receive instruction in Islamic Studies to build character and foster the Islamic way of life. Curriculum for Islamic Studies is "I Love Islam" and "Learning Islam," published by Islamic Services Foundation, Chicago, Illinois.

Arabic: All students K-8 receive instruction in Arabic. The main goal is to develop conversational fluency, with grammar, writing, and reading the Qur'an. Students are placed in beginning, intermediate and advanced levels. The curriculum for Arabic is Iqra', published by the International Education Foundation.

DRESS CODE

As an Islamic based school, our core foundation warrants appropriate attire by all school personnel and students. A uniform policy has been established to promote the Islamic environment, keep students focused on studies instead of fashion, and to maintain personal modesty. Students are required to be in uniforms on the first day of school or have a receipt that you have purchased a uniform and it is being altered.

All uniforms must meet appropriate uniform guidelines and will be inspected by the faculty and staff. If the uniform is not deemed appropriate according to guidelines, parents will receive a phone call explaining the violation and will be expected to pick up their student from school and/or bring uniform in compliance with the standards. The uniform guidelines are:

- Navy Blue or Khaki Pants and white or light Shirt for boys.
- Navy Blue jumper with loose navy Blue pants for girls.
- Jackets: Navy Blue, Black, or Grey for both boys and girls. (No leather jackets, No Logos)
- Please make sure to label your child's jacket, because we have many unclaimed jackets that we donate at the end of the school year.
- Girls in grades 3 and up are required to wear *Hijab* at school and all school sponsored events. The color should be appropriate for school and not distracting for other students.

The following are not appropriate attire for school and will not be permitted inside school.

- Extremes hairstyles
 - · No shaved, half-shaved designs or layered haircuts for boys
 - · Hair should not extend below the eyebrows or ears
- Extremes in style or fit of clothing.
 - · No Cargo pants (pants with pockets)
 - · No leather pants
 - · No flared pants
 - · No Jeans or shorts
 - · No sweat pants, t-shirts, athletic jerseys outside of P.E.

- · No tank tops
- · No sagging, extremely oversized, or extremely tight-fitting clothes
- · No visible brand name labels, emblems, images, designs or logos EXCEPT VCS
- · No caps, hats or hoods from sweater sets
- No Jewelry of any type or during any school activities, with the exception of stud earrings for girls.
- Girls may not wear make-up, perfume, artificial nails or nail polish
- Shoes: Black or white (Walking shoes; sneakers are okay, no boots)
- No jeans
- No hooded sweatshirts or hoodies jackets may be worn during school.

Students not dressed in uniform will not be allowed to attend class.
